Summary Annual Report

For Essex Portfolio L.P. 401(k) Plan

This is a summary of the annual report for Essex Portfolio L.P. 401(k) Plan, Employer Identification Number 77-0369575, Plan No. 001 for the period January 01, 2020 through December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through a trust fund. Plan expenses were \$10,825,441. These expenses included \$226,369 in administrative expenses and \$10,593,999 in benefits paid to participants and beneficiaries and \$5,073 in other expenses. A total of 2381 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$97,030,135, as of December 31, 2020 compared to \$83,982,219 as of January 01, 2020. During the plan year, the plan experienced an increase in its net assets of \$13,047,916. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$23,873,357, including employer contributions of \$2,715,011, employee contributions of \$7,283,277, other contributions of \$690,232, realized gains of \$3,648 from the sale of assets, and earnings from investments of \$13,181,189.

The plan has insurance contracts with KAISER FOUNDATION HEALTH PLAN INC, UNITEDHEALTHCARE INSURANCE COMPANY, VISION SERVICE PLAN, THE GUARDIAN LIFE INSURANCE COMPANY OF AMERICA, NATIONAL UNION FIRE INSURANCE COMPANY OF PITTSBURGH, PA, KAISER FOUNDATION HEALTH PLAN OF WASHINGTON, ARAG INSURANCE COMPANY and MANAGED HEALTH NETWORK to pay certain Health, Prescription drug, HMO contract, PPO contract, Vision, Dental, Life insurance, Temporary disability, Long-term disability, Accidental Death & Dismemberment, Business Travel Accident, Legal, Employee Assistance Program, Accident claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2020 were \$16,764,099.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2020, the premiums paid under such "experience-rated" contracts were \$141,355 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$85,663.
